Dear member,

Writing the first paragraph for the Member's Monthly, I'm starting to feel like the weatherman in *Groundhog Day*; the situation won't go away, but the story never changes! While the House of Commons has outlawed a no-deal Brexit, this doesn't mean one can't happen by accident. It is the default legal position in the absence of an extension which would require EU-27 agreement.

One issue we have been regularly questioned on concerns the import of UK-certified goods, and whether they will remain certified post October 31st. The EU Commission issued a <u>Guidance</u> <u>Document</u> on this back in February. In summary, goods which are 'on the market' are OK for sale, even if they are UK-certified. Of course the issue remains post-Brexit if you rely on a UK supplier-you MUST consider alternative sources of supply.

We're less than one month away from budget day. We acknowledge the difficulties Paschal Donohoe faces in framing a budget 23 days before Brexit, but we fear that he is limited by the budgetary policies he has followed over the last few years: Despite a decade-long boom, we have no primary budget surplus, and a disorderly Brexit could tip us into another recession. Where will he find money to spend without borrowing more? Ireland is by far the most indebted nation in the EU on a per-capita basis. Talking about 'debt-GDP ratios' is meaningless when 32% of our GDP is US money we will never see in our pockets. It is long past time to reduce the €42,000 every man, woman and child in the country owes.

As most of you are no doubt aware, the insurance issue has not improved, and it's not going away. We will keep pressure on Justice Minister Charlie Flanagan, who will have to do most of the heavy lifting to solve the problem. We are very unhappy with the stalling of insurance reform. This will be an election issue, and our informed sources (and bookies!) suggest we're in for a February General Election- possibly with no return after the Christmas recess.

Our regional <u>ISME Roadshows</u> have been a big success with members. After a break to facilitate the Annual Conference, we'll resume them soon.

It really is our best line-up ever for the ISME Annual Conference- with Dublin five-in-a-row Manager Jim Gavin, Norah Casey, and some meaty panel discussions (including a serious Brexit panel line-up). This year's conference is a must-see, and you can get your tickets <u>here</u>. I look forward to seeing you!

Construction SEO Updates – As of 1st October 2019

As of 01st October 2019 the new updates of the Construction SEO come into force. The following is a breakdown of the key changes however ISME are advising all members that are impacted by this to review the document which is available on the ISME website.

Key Changes

- New definitions for the sector
- Rates of pay increases scheduled on 01/10/2019 & 01/10/2020 - as outlined
- Extension of New Entrant period to two years of service.
- Clearer identification of Category A workers
- Increase in Pensions and Death in Service payments to match the salary increases.

Definition of the Sector

The sector to which the Order should have application is defined as the sector of the economy comprising the following economic activity:

- The construction, reconstruction, alteration, repair, painting, decorating, fitting of glass in buildings and demolition of buildings;
- The clearing and laying out of sites for buildings, the construction of foundations of such sites, the construction, reconstruction, repair and maintenance within such sites of all sewers, drains and other works for use in connection with sanitation of buildings or the disposal of waste;
- The construction, reconstruction, repair and maintenance on such sites of boundary walls, railings and fences for the use, protection or ornamentation of buildings, the making of roads and paths within the boundaries of such sites;

 The manufacture, alteration, fitting and repair of articles of worked stone (including rough punched granite and stone), granite, marble, slate and plaster;

HR ADVICE

- The construction, reconstruction, alteration, repair, painting, decoration and demolition of roads, paths, kerbs, bridges, viaducts, aqueducts, harbours, docks, wharves, piers, quays, promenades, landing places, sea defences, airports, canals, waterworks, reservoirs, filter beds, works for the production of gas or electricity, sewerage works, public mains for the supply of water or the disposal of sewerage and all work in connection with buildings and their sites with such mains; rivers works, dams, weirs, embankments, breakwaters, moles, works for the purpose of road drainage or the prevention of coastal erosion, cattle markets, fair grounds, sports grounds, playgrounds, tennis-courts, ball alleys, swimming pools, public baths, bathing places in concrete, stone tarmacadam, asphalt or such like material, any boundary walls, railings, fences and shelters erected thereon;
- The painting or decoration of poles, masts, standard pylons for telephone, telegraph, radio communication and broadcasting;
- Ground levelling, ground formation or drainage in connection with the construction or reconstruction of grass sports grounds, public parks, playing fields, tennis-courts, golf links, playgrounds, racecourses and greyhound racing tracks.

Definition of Grades and Pay Rates General Operative Grade B

A basic minimum rate of pay to apply to all Skilled General Operatives who have worked in the sector for more than 2 years - (**Category B Worker**)

€17.50 per hour (increase of €0.46 / 2.7%)

General Operative Grade A

Scaffolders who hold an Advanced Scaffolding Card and who have four years' experience; Banks operatives, Steel Fixers; Crane Drivers and Heavy Machine Operators.

€18.86 per hour (increase of €0.50 / 2.6%)

Craft Workers

Individual Dispute

- a) The grievance or dispute shall in the first instance be raised with the employer at local level with a requirement to respond within 5 working days. Notice in writing of the dispute shall be given by the individual concerned or his trade union to the relevant organisation representing employers or to the employer directly.
- b) If the dispute is not resolved it shall be referred to the Adjudication Service of the WRC.

c) Either party can appeal the outcome of the Adjudication Hearing to the Labour Court.

Collective Dispute

- a) The grievance or dispute shall be raised in the first instance with the employers with a requirement to respond within five working days. Notice in writing of the dispute shall be given by the workers concerned or their trade union to the relevant organisation representing employers or to the employer directly.
- b) If the dispute is not resolved the issue shall be referred to the Conciliation Service of the WRC.
- c) If the issue remains unresolved, it shall be referred to the Labour Court for investigation and recommendation.



October Dividend Withholding Tax

14th Due date for payment and filing of returns of withholding tax on dividends paid by companies in September 2019.

Income Tax

23rd Payment of PAYE/PRSI/USC/LPT deductions for September 2019 (ROS filers).

Corporation Tax

23rd Company year-end 31st November 2019: Preliminary tax due, minimum 90% of total liability for the year. Small companies can pay 100% of previous year's liability (ROS filers). Company year-end 31st January 2019: Payment of balance of corporation tax and filing of corporation tax return (ROS filers).

Company Secretarial

28th Filing of Annual Returns dated 30th September 2019.

Corporation Tax

Company year-end 30th April 2018: Close companies with undistributed profits may have to make a distribution by this date to avoid surcharge.
 Company year-end 31st January 2019: Filing of 'Return of third-party information' (Form 46G).

Company Secretarial

31st Company year-end **31st January 2019**: Final date for holding Annual General Meeting and latest possible Annual Return date for 2019.

Capital Gains Tax

31st Filing of return of capital gains tax for 2018 tax year.

Income Tax

Filing of 2018 Income Tax return.
 Payment of Preliminary Income Tax for 2019.
 Payment of balance of Income Tax for 2018.

On 9th May 2019, Revenue announced an extension to the ROS Return filing and tax payment date for certain customers. The new deadline of 12th November 2019 applies to Customers who file the 2018 Form 11 Return <u>and</u> make the appropriate payment through ROS for Preliminary Tax for 2019 <u>and</u> Income Tax balance for 2018.

Contributions to an exempt approved scheme are allowable as an expense in assessing an employee's liability to tax under Schedule E. This is only an income tax relief and does not apply to the Universal Social Charge (USC) and Pay Related Social Insurance (PRSI). The following are the applicable pension plans:

- Occupational pension plans
- Personal Retirement Savings Accounts (PRSAs)
- Retirement Annuity Contracts (RACs)
- Certain overseas plans

Tax relief for employee pension contributions is subject to two main limits under Section 790A TCA 1997:

1. Age-related earnings percentage limit

You can get tax relief on your pension contributions up to the relevant age-related percentage limit of your earnings in any year. This relief is only from the employment in respect of which the contributions are made.

Age	Percentage Limit %
Under 30	15%
30 – 39	20%
40 – 49	25%
50-54	30%
55-59	35%
60 or over	40%

The age-related earnings percentage limits are:

2. Total earnings limit

The maximum amount of earnings taken into account for calculating tax relief is €115,000 per year.

Contributions to more than one pension product

Where an individual has two sources of income e.g. earnings from employment and profits from selfemployment and is making pension contributions to an occupational pension scheme and to a personal pension plan, a single aggregate earnings limit of €115,000 applies in determining the amount of tax relievable contributions.
