MESSAGE FROM THE CEO

Dear member,

It's October, and we're back with a bang.

The six-month forbearance period that banks applied to mortgage debt ends this month. This does not mean that everyone is out of the woods and able to pay their mortgage. It is very important that you talk to your bank NOW if you are still suffering an inability to pay.

A lot of you are about to renew insurance policies. In almost all cases, the cost of your insurance should be falling. We have some pointers from the Alliance for Insurance Reform here.

Insurance reform remains painfully slow. The Tánaiste has promised a lot of Government focus, but we have yet to see action that will reduce your premiums. While the Law Reform Commission has declared that it is constitutional to cap damages, they have also said that the mechanism to fix it is via the Judicial Council. Since the judges put up the awards in the first place, this route is fraught with problems. We have made our views known to the press and the Oireachtas <u>here</u>.

While it was good to see the National Competitiveness Council denounce the scandal of insurance and legal costs in this year's report, they missed the rents issue entirely. Since rents are likely to be the most significant factor for those businesses that become insolvent during the Covid-19 pandemic, this was a significant omission. Our views on the issue are here.

As the budget approaches, and with the Department of Finance pulling the cushions from every sofa in search of money, ISME identified a real threat to private sector pensions. This was the piggy-bank raided by Michael Noonan in the last recession. Those of us who had our money taken a few years back will not see it again. ISME is determined that this State-sponsored theft will not recur. To do this, we need to put the State on notice that State employees are far better treated than private sector workers and entrepreneurs already, and that we are confident that courts would agree with us. We are looking for a number of individuals who are willing to act as plaintiffs in the case. You will find the details here.

As of 1st October, Dublin and Donegal are at Level 3 in the <u>Covid-19 Framework</u>. We want these counties out of Level 3 as soon as possible, and we don't want any more places affected. It is really important for you to lead the public safety message in your business and your locality. The solution to living with Covid-19 isn't more lockdowns, it is the simple recurrent message:

- Washing our hands regularly and thoroughly.
- Observing good cough and sneeze etiquette.
- Maintaining social distancing

Please drive these messages as hard as you can.

Lastly, don't forget the help that is available for you and your staff. There is always someone to talk to. If you haven't considered it yet, have a look at the <u>ISME Wellness Program</u> from Laya, which has a 24/7 Mental Wellbeing Support Programme Employee Assistance Program. You are not alone.

Ready for Customs

Regardless of the outcome of the current negotiations on a Brexit deal, our trading relationship with the UK will change fundamentally and irrevocably on January 1st. While the Brexit process may have been plagued with uncertainty up until now, the only absolute certainty in relation to the trading relationship is that moving goods to, from or through the UK (excluding Northern Ireland) will require a customs declaration from January 1st 2021. That will present a massive challenge for Irish businesses. To put its scale in context, nearly 100,000 Irish businesses trade with the UK. At present, Irish businesses generate around 1.7 million customs declarations annually, but that will rise to 20 million next year as a result of Brexit. The government has put in place a new €20 million Ready for Customs fund managed by Enterprise Ireland to assist Irish businesses to meet this challenge. The Ready for Customs fund provides grants of up to €9,000 for each new full-time employee engaged in customs work. They grant also covers costs associated with redeploying an existing member of staff.

The grants can be used for employee salary costs and a contribution towards overheads, including software and IT infrastructure.

The urgency of the situation cannot be overemphasised. The stark reality is that the United Kingdom will become a third country as far as trade with the EU is concerned from January 1st 2021 and customs procedures will be the new normal. A message from the Alliance for Insurance Reform:



Companies in many sectors are getting ready to renew their insurance cover at the moment so the Alliance Covid-19 Working Group is reaching out about insurance renewals in the current environment with a few pointers:

- By law, an insurer (underwriter, broker or other intermediary) must, no later than 20 working days before renewal, notify policyholders of any alteration to the terms and conditions of the policy (Section 14(6) of the Consumer Insurance Contracts Act 2019). While this applies to organisations with a T/O of less than €3m, we would expect that at the very least, bigger organisations would extend that essential courtesy as well
- In lieu of immediate forbearance, many insurers promised to reflect reduced levels of risk during the first half of 2020 in the new premium when policyholders renewed. We would expect them to honour that commitment at renewal
- Equally, we would expect the majority of liability premiums to fall on renewal due to:
 - Dramatically reduced levels of economic and social activity in many sectors
 - The removal of Covid19, or in some cases any disease-related risk, from policies on renewal (The experience of some pubs is related <u>HERE</u>)

EMPLOYMENT WAGE SUBSIDY SCHEME



EWSS Registration is now open

Eligible employers or their payroll/tax agents can now register for EWSS through ROS. Revenue confirmed the opening of the registration facility on Wednesday 20th August. Employers who are claiming the TWSS must separately register for the EWSS as different eligibility conditions apply to both schemes.

Revenue confirmed that registration applications will only be processed if the employer:

- is registered for PAYE/PRSI
- has a bank account linked to the PAYE/PRSI registration, and
- has tax clearance

The employer or payroll/tax agent must make a self-declaration to Revenue confirming eligibility for the scheme, undertake to adhere to the required terms and conditions and retain all relevant records relating to the scheme.

Registration is effective from the date of application and cannot be backdated. Registration must be undertaken prior to the first payment date for which the EWSS is being claimed. Claims for new hires and seasonal workers can be made from 1st July 2020, subject to limited exceptions. Details on making an application for retrospective EWSS payment is included in Revenue's Guidelines on the operation of the EWSS.

Register Now – EWSS Registration Cannot Be Backdated

Revenue are reminding employers and accountants acting on their behalf to register for the EWSS through ROS if they have not already done so. Revenue are stressing the importance of registering before the first pay date for which EWSS is being claimed, as applications cannot be backdated.

In recent press release, Revenue said:

'Employers who meet the eligibility conditions should take action and register now if they wish to claim EWSS in respect of payroll submissions made on or after 1st September 2020. However, in doing so, employers should be aware that making an application for tax clearance and registering for the EWSS are separate processes. Both processes need to be completed before an employer can access EWSS supports. Additionally, employers who are currently claiming the Temporary Wage Subsidy Scheme (TWSS) must separately register for the EWSS as different eligibility conditions apply to both schemes.'

As of Thursday 27th August, 12,100 employers registered for the EWSS, while 14,800 employers applied for tax clearance.

To qualify for tax clearance, the business and any persons or entities connected to the business must be compliant with all obligations under tax legislation for the filing of tax returns and payment of taxes.

Revenue published updated Guidelines on the operation of the EWSS in early September.
