MESSAGE FROM THE CEO

Dear member,

At the busiest time of the year for many of you, we find ourselves in a Level 5 lockdown. ISME acknowledges the need for aggressive public health measures to control Covid-19 infection numbers, but we are frustrated that lockdown appears to be Ireland's only policy response to this pandemic.

We have written to all TDs and Ministers to press our case that NPHET needs to come up with public health policies that don't kill the patient. You'll find a copy of our letter here.

The Central Bank released its <u>Second Motor Insurance Report of the National Claims Information Database</u>. This proves what many of you already know: the insurers and lawyers continue to enjoy rich pickings at the expense of policy holders. This will be a long war, and we will need to maintain pressure on the Government, and the Justice Minister in particular, if we are to get progress. We will need your help in doing so.

The budget was somewhat of a non-event, but we did get some important issues addressed. The Covid Restrictions Support Scheme (CRSS) which will pay up to €5,000 a week to businesses forced to close temporarily because of Covid-9 restrictions. We secured the reduction in VAT for the hospitality sector to 9%, although we would like to have seen the 21% VAT rate put on a permanent footing. The extension of the Emergency Wage Subsidy Scheme (EWSS) to March 2021 and a commitment to introduce a similar type of scheme to run from March 2021 was welcome. And a €3.4 billion Recovery Fund to stimulate increased domestic demand and employment was announced, but we await the detail on it.

We have made some significant progress on 'Examinership Lite.' A lot of businesses will unfortunately become insolvent as a result of the pandemic, but 10%-15% could be restructured if we had an affordable mechanism available to them. We hope to have positive news soon.

With all that's been happening, it's easy to lose sight of the fact that we are just eight weeks away from a disruptive Brexit. Even if we get substantial progress to a deal in November, it will at best be a 'skinny deal' and will have cost and supply impacts on your business. Make sure you visit our <u>Brexit Page</u> to understand what supports are available for you. This IS happening, and IT WILL be disruptive. Don't leave it until January 2nd to do something about it.

Shopping local and supporting local business has never been more important. Stay tuned for our 2020 campaign!

It is natural and human to feel overwhelmed by all the challenges you are facing at the moment, but please don't bear those challenges alone. Make sure you talk to someone about it if it's becoming too much for you- you are not alone.

OVERVIEW OF COVID RESTRICTIONS SUPPORT SCHEME (CRSS)

In his Budget speech on 13th October 2020, the Minister for Finance announced his intention to introduce the Covid Restrictions Support Scheme ("CRSS") as an additional support for businesses subject to significant Covid-19 restrictions. The scheme is intended to be in addition to the supports provided to employers under the Employer Wage Support Scheme ("EWSS").

It is proposed that CRSS will be available to companies and self-employed individuals operating a business, profits from which are chargeable to tax under Case I of Schedule D. To qualify, the business must be operating from a premises wholly located in a region subject to restrictions under the Government's plan for living with Covid-19 "Resilience and Recovery 2020-2021:Plan for Living with Covid-19", with the result that the business is required to prohibit or considerably restrict members of the public from accessing their business premises. Generally, the restrictions apply at Level 3, 4 or 5 of the Plan for Living with Covid-19 but, in the case of certain businesses could apply at lower levels of restrictions.

Where as a result of the restrictions, a business has been required to temporarily shut their premises or operate at significantly reduced levels, with the result that turnover for that period will be no more than 20% of the average weekly turnover for a period equal to the same number of weeks in 2019 (or using 2020 turnover figures for new businesses), that business will qualify under the scheme.

Qualifying taxpayers will be able to log on to ROS and register for CRSS as soon as possible. The registration process will include providing details such as the location of the business and average weekly turnover for 2019. The claims process will be available from mid-November. Once they have registered, a taxpayer will be able to make a claim for the period their business is restricted from operating. Revenue will publish guidelines on the registration process and on the operation of the scheme in due course.

The relief will operate as a cash payment equal to 10% of the average weekly value of the 2019 business's turnover up to €20,000 and 5% thereafter, subject to a maximum weekly payment of €5,000, for the same number of weeks as the restricted period.

The payment is known as an "Advanced Credit for Trading Expenses" and is taken into account when computing the profits and gains of the business under Case I of Schedule D as a reduction against deductible trading expenses. However, the receipt of the payment will only result in additional tax where the business is in a profitable position for the chargeable period.

The scheme will operate on a self-assessment basis and is conditional on the taxpayer continuing to file all tax returns on time, holding a current tax clearance certificate and on the intention to resume the business when the restrictions are lifted. Details of taxpayers availing of the scheme will be published on the Revenue website at a later time.

The Scheme will run from 13th October 2020 until 31st March 2021.
