## SME MESSAGE FROM THE CEO



Dear member,

Since last month, we have seen twin crises emerge in energy: one regarding energy prices, the other regarding energy supply.

The energy price crisis has many causes, and the war in Ukraine has exacerbated them because so much electricity generation is gas based. The Department of Enterprise has shared their Energy Supports for <u>Business</u> with us, however, must of these are too long term to be of any assistance this winter. While we polled members on their willingness to join an energy purchasing group, it is clear that suppliers have no interest in setting up new purchasing groups at the moment.

The issue of energy supply is not yet with us, but there is a significant risk of disruption this winter because of our lack of back-up capacity for wind, the absence of a gas interconnector to the continent, and our lack of gas storage. What is particularly infuriating about the emergence of this crisis now is that these energy risks were identified in Ireland's first National Risk Assessment in 2014. Yet the State did nothing to mitigate the supply risks it had identified. This is unacceptable, and we must collectively hold our Government and public service to account for so serious a failure.

We have made our position clear. The magnitude of the energy crisis will require State supports for SMEs similar in size to those been undertaken in other EU states.

No one takes issue with the desire for workers to address their cost of living through higher wages. All employers are experiencing similar wage pressures. But the reported size of the deal at a time when there will be a need for crisis measures on energy is very worrying. Here is our reaction to the deal.

It's not all bad news though. After two plus years of pandemic mayhem, we're back on the road for our member's meetings starting in September. Here are the details for our ISME Roadshows.

#### Public sector pay demands represent selfinterest not the national interest

ISME understand the pressure on public sector pay because of inflation, the fact is that the public service already enjoys wages that are 22% higher than the average private sector wage, and 46% higher than the average small business wage.

Public sector employees also have well-documented benefits and job security far beyond those enjoyed by others in the workplace.

Neil McDonnell, CEO, ISME, said: "Ireland has number of concurrent crises to deal with including housing, inflation and security of energy supply. Tackling these issues will be capital-intensive and must be the priority for Government, citizens and society. If we throw our budgetary space at the public sector, we diminish the ability to tackle the other, more urgent crises.

This is on top of the continuing impact and aftermath of the Covid-19 pandemic; the ongoing uncertainty arising out of Brexit and the more recent and atrocious Russian invasion of Ukraine. We must NOT allow reckless public service union self-interest prevailing over Ireland's national interest."

The Government must stand up to any threat of strikes by any Union in the public sector. It has to take a balanced view for the other 85% of the workforce not working in the public service and it cannot allow itself to be informed or influenced by any Union threat to go on strike.

The Rates Revaluations that were due to take place in 2019 were postponed due to Covid-19. We understand that the Proposed Certificates are now being issued in September 2022.

The Valuation Office are extremely strict on deadlines and there is no leeway. There is a statutory process involved in the revaluation and it is essential that ratepayers prepare and take action well in advance. Time is of the essence and we recommend that all property inspections take place as soon as possible.
